PLEASE NOTE: Parent helpers/volunteers are NOT PERMITTED to be involved in ANY football activities with the children (including their own child) at a training session or matchday environment until confirmation of a successful CRC check is received and approved by the Club Welfare Officer. It is acceptable to help carry equipment, balls, cones, set up goals etc.

4: Anyone helping out regularly at training or matches as an assistant coach MUST also complete the FA Safeguarding Children and FA Emergency Aid courses within 3 months of their application. Failure to do so will result in suspension from volunteering activities. PLEASE NOTE: No parent helper/volunteer is permitted to identify themselves as a Team Official by wearing club-branded (badged and/or initialed) clothing until they have received confirmation of an FA Enhanced CRC check and hold the FA Safeguarding Children and FA Emergency Aid qualifications. Failure to observe this policy may result in disciplinary action which could include suspension from volunteering activities.
